Pastor's Corner



In each Newsletter, our Parish Priests are invited to share their thoughts on Right to Life issues. In this March for Life Edition, Father Bernard Vellozo (St. Francis of Assisi Parish) offers his insights.

From the Desk of Father Bernard Vellozo

"Section 7 of the Canadian Charter of Rights and Freedoms states that: "Everyone has the right to life..." Sadly, due to the non-recognition of an unborn baby as a human person until it has been born, over one hundred thousand babies are aborted in Canada every year.

Saint John Paul II referred to the "culture of death" when speaking about our times. Many of the behaviours that our culture has embraced have resulted in the devaluing of the inherent dignity of the human person. The callous and cavalier attitude towards life was once again demonstrated by the Supreme Court of Canada in its recent decision regarding assisted suicide. Pope Francis has spoken about this "throwaway culture" in a recent speech to Catholic gynecologists: "Every unborn child, though unjustly condemned to be aborted, has the face of the Lord, who even before his birth, and then as soon as he was born, experienced the rejection of the world. And every old person, even if infirm and at the end of his days, carries with him the face of Christ. They must not be thrown away!"

In the face of the onslaught on the dignity of human life, from conception until natural death, every person of good will has a responsibility to do something. First, we must take the time to educate ourselves on the facts. We cannot intelligently respond to this "culture of death" if we are not well-informed about the behemoth that we are dealing with. Secondly, we must fast and pray that the Lord may empower us by His Spirit to work to build a culture of life. We cannot merely fight against something; we must also provide a better alternative. Finally (and I say this as a priest), we must support and encourage our clergy who have the courage to speak about pro-life issues in the midst of a very hostile society. I am convinced that if everyone who reads this reflection were to get more involved, we could, with God's grace, make a difference in speaking up for the dignity of every human person."

A Birthright Story

“Sometimes when one reads LifeNews, for example, the really disturbing things that are going on nationally and globally can be very disheartening. There are many victories reported too, so by all means keep following such sites. We'd like to share with you just a few of the encouraging developments in our pro-life community, which demonstrates that we are winning this battle....

On March 25th, St. Anne's Church in Brampton will have celebrated its 12th annual Mass for the Unborn. This tradition began back when Father Damien Ali was the spiritual advisor for the KoC Council for St. Leonard's Church in Heartlake. When Father Damien became pastor at St. Anne's Church, the Mass for the Unborn started being celebrated there. The Knights of Columbus Council 9235 continue to provide an Honour Guard at the Mass. In addition, parishioner Marilyn Brown has worked hard to make the evening special. She began by organizing a Baby Shower, whereby Mass participants were asked to bring diapers, baby food, clothes etc., that were donated to Brampton Birthright. This is still the case. Then Marilyn started to invite guest speakers who would give a talk after the Mass. These included: Father Tom Lynch of Priests For Life, Angelina Steenstra from Silent No More, former prochoice news reporter, and subsequent convert Nancy Kelly, Sisters for Life, Alex Schadenberg from the Euthanasia Prevention Coalition, Pauline Murphy, Director of Brampton Birthright and Jim Hughes from Campaign Life Coalition.

This year Bishop John Boisseneau is the Main Celebrant, and Mass will be followed by the viewing of the movie Crescendo. Once again pro-life organizations will display their information as participants gather for fellowship. Many thanks to the Knights of Columbus council and to Marilyn Brown for working hard to continue this beautiful tradition honouring life at all stages. Also in Brampton, the Birthright office just celebrated its 18th year of operation by hosting an Open House at its new location: the Honourable William G. Davis for Families, 60 West Drive, suite LL1. Every year, Birthright Brampton helps over 100 women and their babies. Dedicated volunteers provide help, love and support to women facing unplanned pregnancies. One woman shares her testimony:

"The doctor told me I couldn't get pregnant because of my kidney problems and so when I did become pregnant, I was shocked and totally unprepared. Having children wasn't in my life plan due to what I had been told. I was having an extremely difficult time in my life... my circumstances were not very good and I was about to be homeless and alone. The doctor and the specialist recommended abortion since I needed dialysis and the pregnancy could have been life threatening. The babies (by this time I knew I was pregnant with twins!) most likely wouldn't make it anyway. I was emotionally shutdown and didn't know what to do until a Credit Valley Hospital counselor told me about Birthright. I can't tell you enough about what Birthright did for me. They really helped me not just materially but emotionally as well. I am so thankful to have had the support that Birthright gave me; they helped me to find my inner strength. Today I am filled with the wonder and the joy of my miracle babies! They are here today thanks to Birthright and I will forever be grateful." – T. A. (The Brampton Guardian, February 23, 2015)

Congratulations to all the brave moms and the Birthright volunteers who generously share their time and talents to be there for them! Finally, we want to tell you about another exciting milestone. In the New Year, after much prayer, several individuals from Maximillian Kolbe Church began a brand new Ministry there. With the encouragement of their Pastor, Rev. Janusz Blazejak, a pro-life group now meets monthly. They hear guest speakers on the life issues, plan pro-life events such as the bus trip to Ottawa for The March for Life and PRAY. In fact, at the time of writing, they are hosting a 40 Days For Life. What's unique is that this campaign is not outside a Mississauga abortion clinic; rather this time the prayer vigil is held in the Eucharistic Adoration Chapel at Maximilian Kobe Church. Up until Easter, from 8 in the morning til 8 at night, someone is praying for moms in crisis and their unborn babies. Alleluia! While there is much to be done, much is being done and for this we take heart."

“South Korea Pastor’s “Drop Box” Saves Abandoned Babies From Infanticide”

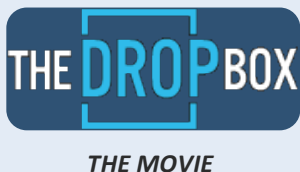

“Lee Jong-rak is a Korean pastor in South Korea. A simple man with a huge purpose, Pastor Jong-rak saw a devastating problem. He thought of a way he could change it, and he became a prophetic voice to his society. His story is a story of faith. A story of hope. A story of love. And when you hear this heroic tale, you just may never be the same.

Lee Jong-rak is the creator of the Baby Box. His Baby Box is the first and only box in Korea that is for collecting abandoned babies who are physically or mentally handicapped or are just unwanted by their mothers. Hundreds of unwanted babies are abandoned on the side of the street in South Korea every year. Jong-rak knew he needed to set up a way to save the lives of these precious babies. He built a drop box on the side of his home with a humble sign reading, “Place to leave babies.”

The inside of the box contains a thick towel covering the bottom, and lights and heating to keep the baby comfortable. A bell rings when someone puts a baby in the box, then Jong-rak, his wife, or staff associates come to immediately move the baby inside. His aim was to provide a life-giving alternative for desperate mothers in his city of Seoul. He even admits that he didn’t really expect that babies would come in – He was mistaken. The babies came. In the middle of the night, in the middle of the day, some with notes, some without a word, and only a very few mothers actually spoke to him face-to-face. Pastor Jong-rak stated that one of the mothers said, “she had poison to kill both herself and her baby.” He responded, “Don’t do that. Come here with your baby.” [...] Yes, this little box is a safer place than the plans that once haunted this single mother’s mind. Because this box was an alternative, she chose life. Thus, this box would be the beginning of an previously undreamed ministry in Korea, the ministry of the Baby Box.”



Every Human Life Is Sacred And Worthy Of Love

“Hundreds of unwanted babies are abandoned on the streets of Seoul, South Korea, every year, forgotten by the surrounding culture. *The Drop Box* is a documentary about the work of Pastor Lee Jong-rak and his heroic efforts to embrace and protect his community’s most vulnerable children. By installing a drop box outside his home, Pastor Jong-rak provides a safe haven to babies who would otherwise be abandoned on the streets to die. It’s a heart-wrenching exploration of the physical and emotional toll associated with providing refuge to save those deemed unwanted by society. But it’s also a story of hope. And a celebration of the reality that every human life is sacred, has a purpose and is worthy of love.”

A Dangerous Euthanasia Ruling

“The Supreme Court of Canada has made an activist decision by giving physicians the right in law to cause the death of people by euthanasia and assisted suicide. The Court has made an irresponsible decision, what is more, by using imprecise and subjective language, leaving many issues to be determined by Parliament without objective criteria. The decision sets a dangerous precedent that, if unchecked, will lead to the sort of abuses that are now common in the Netherlands, Belgium and Switzerland.



The decision allows euthanasia and assisted suicide for not only physical but also psychological suffering, without limiting it to clear parameters. Because there is no clear definition for psychological suffering, the Court has opened a Pandora’s box. Psychological suffering was the reason for the following deaths in the Netherlands: a healthy woman, with tinnitus, died by euthanasia; a healthy man who was lonely, depressed and recently retired; a healthy woman who was deaf died by euthanasia; among many other cases.

The decision legalizes euthanasia for “a competent adult person who (1) clearly consents to the termination of life and (2) has a grievous and irremediable medical condition (including an illness, disease or disability) that causes enduring suffering that is intolerable to the individual in the circumstances of his or her condition.” One would assume “competent adult person” is clear enough, but what if that person is depressed?

In Oregon, where the assisted death law is limited to people with less than six months to live, Dr. Charles Bentz has written about his long term patient who was diagnosed with depression yet died by assisted suicide – under a law that claims to protect depressed people from assisted suicide. Competence is very difficult to determine. Similarly, the Belgian law requires that the person be competent, and yet Dr. Tom Mortier’s mother died by euthanasia even though she was experiencing situational depression related to a relationship break-up. The decision states that the person must clearly consent. But what if a person is unable to consent? Recent statistics from the Netherlands indicate that there are at least 300 assisted deaths without consent each year. The statistics also indicate that these assisted deaths are rarely reported.

Will abuse of the law occur? How could it not? The Supreme Court states that the person must have “a grievous and irremediable medical condition and irremediable condition (including an illness, disease or disability)”. But this is an incredibly subjective statement; many people have a grievous and irremediable medical condition. Indeed, under this definition, nearly every person with a significant disability may now feel pressured, by friends, or the medical system itself, to choose euthanasia regardless of their personal preferences.

Further, the decision states that the person’s condition must “cause enduring suffering that is intolerable to the individual in the circumstances of his or her condition”. The statement conjures up thoughts of excruciating pain, but in fact this is also a very subjective statement, in as much as it is based on what is intolerable to the individual. There is no objective standard. The subjective language of the decision, if implemented in legislation, would lead to assisted death becoming the norm in all of the situations in Belgium and the Netherlands that have led to such international concern.



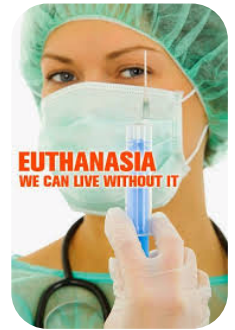


A Dangerous Euthanasia Ruling (cont'd)

Giving doctors the right, in law, to cause death to their patients will never be safe and no amount of so-called "safeguards" will protect us from depression or abuse. There will always be people who abuse the power to cause death and there will always be more reason to cause death. The fact that death for psychiatric conditions tripled in the Netherlands in 2013 should concern every Canadian after this decision. The fact that very few people ask for euthanasia based on physical suffering, and even in those cases the pain can be mitigated, should give us hope that no one actually needs to die this way.

Assisted suicide creates a new path for the abuse of elders, for people with disabilities and for other socially devalued people. Depression, in particular is common for people with significant health conditions. Assisted suicide represents an abandonment of people who live with depression who require support and proper care, and undermines the important mental health and suicide prevention programs.

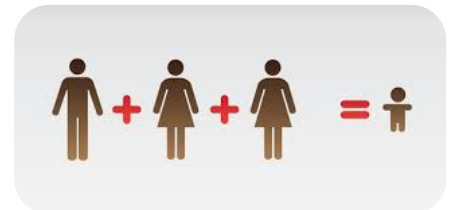
Since an election will likely occur in October, the Euthanasia Prevention Coalition is asking the government to use the notwithstanding clause to gain the time necessary to craft a law that can still protect Canadians. We must not abandon Canadians to the false lure of assisted death, but must keep up the fight on behalf of the vulnerable and the disabled, until the day a future Supreme Court decision overturns this activist decision."



(British) MPs Vote in Favour of 'Three-person' Babies *Source: ITN*

"In historic debate Commons votes for controversial change to genetics law to allow mitochondrial transfer. MPs have voted in favour of making Britain the first country in the world to permit IVF babies to be created using biological material from three different people to help prevent serious genetic diseases.

In a historic debate, the House of Commons voted by 382 to 128 - a majority of 254 - to allow mitochondrial donation through a controversial amendment to the 2008 Human Fertilisation and Embryology Act. They approved the regulation in spite of some critics warning it was a step towards creating "three-parent" designer babies. The regulations will now have to be approved in the House of Lords, where they are likely to be passed. MPs were allowed a free vote on the issue of conscience but both the Conservative and Labour front benches made it clear they believed it was an important scientific step forwards that did not amount to genetic modification.



Jane Ellison, the Conservative public health minister, told MPs the techniques provided in the regulations offered the only hope for some women who carried the disease to have "healthy, genetically-related children" who would not suffer from the "devastating and often fatal consequences" of mitochondrial disease. She said mitochondrial DNA made up 0.054% of a person's overall DNA and none of the nuclear DNA that determined personal characteristics and traits.

Critics of the motion had been given hope of defeating it after the Church of England and the Catholic Church in England and Wales said it was not yet clear that the technique was safe or ethical. Opposition was led by Conservative MP Fiona Bruce, who said parliament needed more time to debate the issues. "I believe the regulations before us today fail on both counts, ethics and safety, and they are inextricably interlinked," she said. "One of these procedures we are asked to approve today, pronuclear transfer, involves the deliberate creation and destruction of at least two human embryos, and probably in practice many more, in order to create a third embryo which it is hoped will be free from human mitochondrial disease. "Are we happy to sacrifice two early human lives to make a third?" Several other MPs objected to the shortness of the 90-minute period for debate, saying a subject of such ethical controversy should be given more time for consideration. However, the minister said mitochondrial donation had been subject to extensive scrutiny for years and it was now time for MPs to vote.



Andrew Miller, the Labour chairman of the science and technology committee, urged his colleagues to back the "overwhelming interest" of those families who have suffered from mitochondrial disease. "I put it to this house that the benefits to those - about 2,500 families - affected by mitochondrial disease up and down this nation, they deserve the support of this house because of the potential benefits," he said. "Yes, of course, we've got to assess the risks as we do with all risks but they've got to be done in a rational and balanced way."

Mitochondrial diseases are caused by genetic faults in the DNA of tiny structures that provide power for the body's cells. The DNA is held separately to the 20,000 genes that influence a person's identity, such as their looks and personality. Because mothers alone pass mitochondria on to children, the diseases are only passed down the maternal line. Around 40 scientists from 14 countries have urged the British legislature to approve laws allowing mitochondrial DNA transfer.

The "three parent" IVF therapy, which could help to eliminate certain incurable genetic diseases, involves swapping a fraction of a mother's DNA with that from an anonymous female donor. Around 100 children each year are affected by genetic defects in the mitochondria and in around 10 cases the defects cause severe illnesses such as liver failure, muscle wasting, blindness and brain damage. The mitochondria sit outside the nucleus of cells and contain tiny quantities of DNA. Mitochondrial genes provide the cells' energy, rather than conferring inherited traits such as appearance, intelligence or personality, and are sometimes referred to as cellular "batteries".



The mitochondria are passed down the maternal line, meaning that any mutations are guaranteed to be passed on to the next generation. However, scientists will now legally be able to prevent this happening by taking two eggs, one from the mother and another from a donor. The nucleus of the donor egg is removed, leaving the rest of the egg contents, including the mitochondria, and this is replaced with the nucleus from the mother's egg. This can be carried out either before or after the egg is fertilised with sperm.

Technically the baby would have three biological parents, with 99.8% of genetic material coming from the mother and father and 0.2% coming from the mitochondrial donor. Dr Jeremy Farrar, director of the Wellcome Trust, said: "Families who know what it is like to care for a child with a devastating disease are best placed to decide whether mitochondrial donation is the right option for them. We welcome this vote to give them that choice, and we hope that the House of Lords reaches a similar conclusion so that this procedure can be licensed under the UK's internationally-admired regulatory system." Prof Alison Murdoch, head of Newcastle Fertility Centre at Life, which has pioneered the IVF technique, said: "This is good news for progressive medicine. In a challenging moral field, it has taken scientific advances into the clinic to meet a great clinical need and Britain has showed the world how it should be done."

These experiences of listening to the stories of rescuers and survivors motivate her enthusiasm for responsible citizenship that affirms human dignity.
