

# A Presentation from Michelle Caluag, Executive Director, Toronto Right to Life to Youth

Sponsored by Right to Life Mississauga & Area

In February, our youth ministry was blessed with the opportunity to have Michelle Caluag, Executive Director Toronto Right to Life, as a guest speaker to present to our teens in Grades 9 to 12. Michelle spoke about abortion and tackled the difficult question – is abortion a human right or a human rights violation? In a society where abortion is easily accessible and often encouraged to those with unwanted pregnancies, abortion is often recognized as a human right.

However, Michelle was able to deliver an insightful presentation that challenged this way of thinking and gave our youth a lot to reflect about. Many of the youth who attended, left the event feeling more informed about the "medical procedure" and re-affirmed that we should all be advocating for life at all stages instead.

Michelle accomplished this by focusing on the proposed question, "where does life truly begin?" She walked us through all stages of fertilization through development of the fetus in an easy way for us to understand. Slowly but surely, as the facts continued to be shared, and as we watched the videos our teens saw the reality that society often does not speak about. These fetuses are human beings that we should be protecting at all developmental stages. Michelle also shared real life examples, hi-liting real mothers and their children, which really put everything into perspective.

We are so grateful to Michelle for taking the time to educate our youth on abortion, as it is often seen as a taboo or "awkward" topic to speak about. It's important that our youth are being informed on matters such as this, and are given safe spaces where they can ask questions and speak to knowledgeable persons, who can ultimately guide them in their thought processes so that they can make educated decisions now and in the future. Philip Horgan

Philip Horgan obtained a B.A, from the University of Toronto, and a J.D. from Queen's University. He was called to the Bar in 1988, and served in large and small firms, before opening his own practice in 1996. His general practice involves a broad range of services, from litigation in constitutional issues, construction, employment, insolvency, defamation, and family areas, to general practice in wills and estates, real estate, and entrepreneurial engagements. He has appeared in trial and appellate courts across Canada, and has participated in numerous cases before the Supreme Court of Canada. Mr. Horgan was elected as a bencher of the Law Society of Ontario in 2019, and was thereafter appointed to serve as an adjudicator of the Law Society Tribunal. Mr. Horgan also serves on the Senate of the University of St. Michael's College in Toronto, and on the boards of charitable and non-profit agencies, including the Thomas More Lawyers' Guild of Toronto, the Faith and Freedom Alliance and the Catholic Civil Rights League.

The visible, public centerpiece of 40 Days for Life is a focused, 40-day non-stop, 7:00am-7:00pm prayer vigil across from the abortion facility. It is a peaceful and educational presence. Those who are called to stand witness during this daily presence send a powerful message to the community about the tragic reality of abortion.

In 2020, we were undeterred by Covide-19 by providing hand sanitizer and safe distancing guidelines (clearly marked at the vigil site). We expect that as vaccinations continue to roll-out across the community during the summer and into the fall, we will see greater numbers of participants covering even more hours throughout the 40 days.

# Much love, More than a glimmer of hope

## Supreme Cowardice of Canada

On February 18, 2021 the Supreme Court of Canada refused, without providing reasons, to hear the constitutional case launched by Mary Wagner. This challenge was to address what her lawyer, Charles Lugosi (a Constitutional lawyer) called a "once-in-a-century" question..."does Parliament have authority to define who is and who isn't a human being". "To pretend an unborn child is not a human being is a fantasy," said Lugosi. Mary's legal team had the scientific testimony of expert witnesses to prove the humanity of the unborn child. Common sense, biology, makes it all clear. Yet recognizing this would have opened the abortion issue wide open, something that our elected officials are deadly afraid of. "If an unborn child is a human being there is no legal principle in common law that permits abortion, which would be culpable homicide under common law", said Lugosi.

Upsetting and discouraging as this was for all who faithfully continue to fight for the unborn, we must not lose hope. Hope risen from ruin drives persistence. Let us keep our heads up, believe that God is victorious. Mary's words to us are encouraging...



## Much Love and in Communion of Prayer

"The Supreme Court's rejection of our application to appeal on behalf of our most vulnerable brothers and sisters disappointed many, to say the least. Much prayer and generosity poured forth from so many people who hoped that our case would help to end the killing in our country of over one hundred thousand helpless babies every year.

Even though this case was a very important fight to fight-because, as Dorothy Day remarked, "The law helps us to be good"-and even though it hit me hard to consider the ramifications of this refusal and the possible spiritual implications for the judges who refused to hear our plea, I have not lost hope. I strive to live as a Christian and am encouraged by what Mother Teresa had said many times: "We are not called to be successful, but faithful". She did not mean that successfully reaching our goals does not matter. She meant that our most important goal as Christians is to cling to Christ; to be faithful to Him till the end-to the Cross- and that it is up to Christ to work things out as He knows best.

More and more, Mary, Mother of Jesus and Our Mother, helps me to have hope, and she leads me to grasp that, indeed, Christ is our Hope. She said "Yes" to becoming the mother of the Saviour of the world. She did not know in advance how much suffering there would be, how much she would have to endure because of what her beloved Son would endure... but she could never lose hope, because she had faith in the promise of the Father and in her Son who said, "Whoever believes in me, even if he dies, shall live" (John 11:25).

There is much darkness in the world around us, (and this Lenten season provides more opportunities for the essential work of facing the darkness within our own hearts and bringing it to Jesus), and only the Light of Christ can cast it out. I must admit that sometimes I wonder how much worse things can get... But then I remember that the worst already happened on the day that Jesus was crucified.

Mary lived through the worst moment in history. As Jesus agonized on the Cross, as He gasped for his last breath, as He was buried and remained in the tomb, she experienced unfathomable suffering, yet she did not give up; she did not despair. She held fast to the promises that were made, even when she did not understand. Her faith was rewarded when she saw her Son on that first day of the week, her Son who says of Himself "Behold, I make all things new" (Revelation 21:5).

Since Mary has walked through the valley of the shadow of death, let us look to her to help us to "fear no evil", and to keep our gazed fixed on the One who has conquered death in all its forms and whose Victory lies in "making all things new", especially the human heart, through his Cross and resurrection.

Upon thanking Mary for her heartfelt reflection, she responded with the following: "You are welcome. I thought afterwards that I did not write it as a letter but more as a reflection... I am praying for your group! Please remind them that those who have been involved in killing the babies have witnessed fewer abortions whenever someone is outside praying!"

# Interview for Saturday Prayer Group

Maximilian Kolbe Parish Pro-life members interviewed by Jolanta Galazka

Members of Kolbe Pro-life group at St. Maximilian Kolbe parish meet faithfully every Saturday morning, rain or shine, at the abortion clinic in Mississauga near the Trillium Hospital. The prayer ministry has been ongoing for many years. They are a prayerful witness to the atrocity of abortion in Canada. Their prayers are directed for the unborn, their mothers and fathers, all who promote and carry out abortions and our country where the killing of babies in the womb is legal under the law. St. Maximilian Kolbe's commitment serves as a model for constant vigilance for other parishes to follow. Here is a short interview with some of the members.

Jolanta: Are you praying here all year round?

Leader: Tom S. and wife Monika

Yes. We have a well-established pattern every Saturday morning. We start with the Holy Mass at our parish at 8 AM. We arrive later by car; we have convenient free parking at nearby St Catherine of Siena church. We walk to Queensway Blvd. and Confederation Parkway and stand on the southwest side of Queensway for about an hour reciting the Rosary and Divine Chaplet.

Jolanta: How is it different presently from the time you first began?

It is different for many reasons; first we can see that there is more openness to this in the Polish parish community, perhaps because now there are fewer group meetings and people have a need to have prayerful contact with others. We do face obstacles due to more and more restrictions in Mississauga. The "bubble zones" started two years ago, so we had to move. We used to stand right next to the abortion clinic and were more visible to people who entered the building. Although we have to stand further away, it is not a problem because we are now very visible to people passing by on the Queensway. Due to Covid-19, we now have social distancing, but that too we see as an advantage in the sense that when we are more stretched, we are also more visible. Therefore, it does not bother us at all. We do have marked places on the street for distancing. All in all, we do not allow these restrictions to deter us from doing our part...to pray



Jolanta: Sometimes people who defend life do not see immediate "fruits of their labour" and become discouraged. What do you say to that?

Every prayer always bears fruit. It is obvious that we would like to see fruits of our efforts right away. When it was the 1st or 2nd day of the 40 Days for Life campaign, we asked for a sign that God would confirm that these prayers were heard. He gave us many signs and testimonies from people that we should continue to pray. That is what is important. There were women who approached us when we were able to stand closer to the clinic and thanked us that they needed a sign and our presence was that sign.

Jolanta: Are there any signs of sympathy or hostility from the drivers of passing cars?

I must honestly say that I have noticed more expressions of support than hostility. There are more friendly gestures of support.

Jolanta: Do you not feel tired, that the batteries are depleted, that this civilization is ignoring us; ignoring the calls to protect life, not only for babies conceived, but also the elderly?

Participant: Halina P.

At times yes, but that is when I turn to God and wait. During those times , we must remain steadfast and diligent, continuing to pray. God is orchestrating the "bigger picture" while all we see is the present, so it is best to trust Him to intervene in our weak moments. Our Lord asks us that "everything you do for the least of these, you do unto me", so I feel that it is the minimum I can do for Him, to come here and pray once a week and be a public witness for Him.

# Human Rights Argument - The Science Really Is Simple!

My colleague, Cam, often tells people that he doesn't use the principles he learned studying for his biology degree while having conversations about abortion. Instead, he uses those he learned in his ninth-grade biology class. As many times as I've heard him say that and as many times as I've shared that simple science in my own conversations, I wasn't fully convinced that was all that I'd need...until a couple weeks ago.

The basic questions of the Human Rights Argument – "If something is growing isn't it alive?" and "If that living organism has two human parents isn't it human?" – are powerful. I've personally witnessed numerous people change their opinion on abortion as they answered them. They're simple, but they work!

The question which lingered at the back of my mind was: would they always? They may work ninety-five percent of the time, but if I met with someone from the five percent of the population who has dived deeper into the study of science. What would I say to them?

Well, that's just what happened a couple weekends ago while our volunteer team was out knocking on doors. Paired up with one of our wonderful new volunteers, I began a conversation with a lady who was sitting out on her front step. When I asked what she thought about abortion, she didn't hesitate.

"I'm pro-choice," she said.

Then she brought up some of the difficult situations a pregnant mother may have to face. We talked through those and slowly made our way to the science of when life begins and the question, what are the pre-born?

That's when she stopped me and said, "I know all about the science. I'm a scientist."

I paused for a second, as thoughts such as why did I get this street? and she should really talk to Cam! raced through my mind. Thankfully, I remembered the advice I've heard so many times: stick to the apologetics.

So, I said, "That's really cool! So, I guess you know then that the science is pretty simple. I mean, if something is growing – even from one cell, to two cells, to four – isn't it alive?"

Her brow furrowed. "Yes, I guess so."

"And if that living organism has two human parents, isn't it human?"

She hesitated.

I said, "Dogs have dogs, right? And we know that cats always reproduce cats, right? So, what do humans make when they reproduce?"

"Well, another human."

I smiled. "Right! So, if abortion intentionally ends the life of that human, wouldn't that mean abortion is a human rights violation?"

Our conversation continued for a few minutes after that and in the end, she said, "I've never thought through abortion in that way before." She agreed abortion is wrong and said she'd learned something from our conversation.

I had too!

I experienced something which had previously just been head knowledge. I realized that the science is the same for all of us, including those who have studied it at a far greater depth than I have, and the facts really are simple.

The question which remains is what will we choose to do with them?

## March for Life 2021



The National March for Life in Ottawa, typically the largest annual protest on Parliament Hill, takes place in May to mark the passing of the 1969 omnibus bill which decriminalized abortion. Pro-lifers rally in front of our Parliament building and march through

downtown Ottawa, demanding that our political representatives fight for the right to life of every human being.

The National March for Life is organized by Campaign Life Coalition. The event is a forum for pro-life Canadians to demand justice for the 100,000 children who are killed in their mothers' wombs each year across Canada. Abortion is fully funded by taxpayers for any reason or no reason at all, right up to the moment of birth.

The National March for Life began in 1998 with a mere 700 pro-lifers in attendance. At first, there was a bit of support for the March from political, cultural and spiritual leaders, but as the event grew, they started coming. Every year the event has grown dramatically. It brings together Canadians of all ages, including thousands of young people.

Each year, we arrange for several speakers including pro-life parliamentarians, religious leaders and activists, to deliver statements that inspire and encourage Canadians gathered on the steps of Parliament Hill to take action.

Afterwards, thousands of pro-life Canadians begin to march through the streets of Ottawa. They are led by the Ottawa police and volunteer marshals, who keep the route safe and clear.

When the March ends, people re-assemble on the lawn of Parliament Hill and listen to moving post-abortion testimonies by the Silent No More Awareness Campaign, which are followed by a prayer service.

Due to the Covid-19 pandemic, the 2020 march was entirely virtual featuring pro-life movie nights on our YouTube Channel, an online candlelight vigil, online religious services, and a special 'Be Not Afraid" television program on EWTN, followed by a LIVE Virtual Rally and March.
